Dear Parent:

Your son/daughter will be attending Tampa Catholic's Prom on **April 28, 2018**. It is important that your son/daughter be aware of the dance policies that have been put in place by the Administration of Tampa Catholic to provide a positive experience for the students on this very important occasion. Please read the policies below with your son/daughter and sign and return this Policy Acknowledgement for the Tampa Catholic Administration. **This form must be received by the Tampa Catholic High School administration BEFORE any tickets for Prom may be purchased. Students will not be allowed to purchase a dance ticket unless this form is COMPLETE AND RETURNED.**

- **SUBSTANCE ABUSE:** Students at school-sponsored events are not allowed to be either in possession or under the influence of alcohol or any other controlled substance (Student Handbook, page 20).
- **ATTENDANCE:** Doors will open at 6:30pm with dinner to be served at 7:00 p.m. **All students attending the dance must arrive by 7:00 p.m.** They are expected to remain at the dance until 11 p.m. Students arriving at the dance after 7:00 p.m. will not be admitted to the dance, and the parents will be contacted accordingly. The doors will not reopen until 10:45 pm.
- **DRESS CODE:** The dress code is formal. Young ladies may not wear dresses with bare midriffs, bare backs, low-cut tops, slits and openings, made of transparent fabric, styles that show cleavage and skirts that are hemmed at more than three (3) inches above the knee. Inappropriate dress is not permitted at Tampa Catholic High School and not permitted at Tampa Catholic functions including Homecoming and Prom. For young men, formal means a tux or suit including tie, dress shirt, dress slacks, dress shoes, and socks (Student Handbook, page 17).
- **DANCING:** Dance styles are to reflect the values of a Catholic school as communicated by the Tampa Catholic Administration. Warnings that remain unheeded may result in the removal of the students from the dance and parental notification, and, if necessary, disciplinary action.
- **TRANSPORTATION:** Students attending the Prom **MAY NOT** arrive in any vehicle, leased, rented or otherwise that has a capacity greater than ten (10) passengers. This includes Party vans, Party buses, extended limousines, and extended SUV-type vehicles. In order to ensure the health, safety and well-being of all attending please make sure to provide us with the transportation information and contact information on page 2 of this form.
- **Failure to comply with the above could result in penalties assessed for future school activities and events and could forfeit your child's participation at this event/dance.**
- In case of an emergency a school administrator can be contacted at the dance site at 813-877-6688 (ask the operator for either Dean Globokar or Mr. Meyer).

It is our hope that your son/daughter has a wonderful time. We feel by making you aware of this information, you can feel confident that your son/daughter will have a fun and safe Prom experience.
